### **New Research Report:**

We are very pleased to launch the report [Preventing Hate Crime](#) as part of National Hate Crime Awareness Week in the UK. The report is published by the International Network for Hate Studies in partnership with the Crime Research Centre at the University of Sussex. The report is a comprehensive review of current hate crime interventions being used in England and Wales. Researchers conducted two round-table events earlier this year with experts, policy-makers and practitioners who informed the report's recommendations on how criminal justice agencies can more effectively combat hate crime.
